 - a. Friends of the Commission \$9619.69
 - b. Grant: Chair Hamilton reported that SCWG has received the official letter from the California Commission on the Status of Women & Girls which has awarded SCWG \$25,000. Some of the funds will go toward hiring a consultant for several events such as Birth Justice 2024, collecting resources to include on SCWG website;

Period Project 2024 (products & ads), Women in Money Workshop (financial literacy). Commissioner Nicodemus made a motion to approve the Women's Recovery Response Commissioner Paul made a motion to second.

Unanimous vote.

- MOU: provides clarity of the roles and responsibilities of Friends and SCWF. Commissioners are
 provided with a draft of the MOU. Chair Hamilton says if there are edits, please provide them to her by
 June 21. Friends will meet to discuss, take edits, and vote to approve the MOU. Final MOU then will be
 presented to the SCWG in June. SCWG will need to vote and approve.
- 4. Birth Justice Event on May 6th (Commissioner Henderson): In attendance were young members and babies. Vendors were amazing and there were a few that showed up who did not sign up to be a vendor. Feedback was positive from the public on the day of the event. Attendees were 50-60, including vendors. Chair Hamilton says a discussion to start planning for Birth Justice 2024 with planning starting in the Fall of 2023. Chair Hamilton will create a survey to for vendors and attendees to provide feedback. Survey will be sent to Commissioners, Friends, vendors, and attendees. KCRA 3 Sacramento covered the event via Zoom. Making it better for 2024: Offering transportation for mothers; provide a childcare provider for your children, and a nursing station for mothers. Suggestion to create a video highlights to post on SCWG. Documentarian is Jennifer Gilman.

5. Future Planning

- a. Period Project \$500 from a grant to spend on the Period Project such as reusable diva cups, panty liners; Set up an Amazon "wish list" to purchase items for an individual. Megan Wong shared that unhoused individuals are using the bathrooms at the county public libraries. Solano County Library is looking to provide products for unhoused women. A concern was brought up to make sure that biodegradable items are considered. Megan shared that Kaiser Solano is having another round of grants and she hopes that the County will be a beneficiary of the latest grant. In the future, the intention is have SCWG partners with Solano County Library to replenish items for unhoused women.
 - Chair Hamilton suggests assigning a point person to manage the project.
 - Commissioner Sanchez is the Chair of the Period Project of 2023 and will take on the role of setting the goal, mission, and outreach efforts.
 - Goal is to have a flier in June to make the request for items from the public.
 - Commissioner Cruz will create graphics for the flier.
 - Working committee for the Period Project will hold its first meeting on Monday, June 5 at 6:00PM. The
 meeting will be virtual via Microsoft Team.
 - Commissioner Kohn says she will create a budget document to submit to the Friends.
- b. October 2023 Celebration 5th Year Anniversary of SCWG Commissioners, friends, public; could charge for the event sponsorships, raffles; discussion to host the event at a venue and charge guests.
- c. Other Events and Workshops for 2023:

Memorandum of Understanding Between

Friends of Solano Commission for Women and Girls and Solano Commission for Women and Girls Draft 6.12.23

The Friends of Solano Commission for Women and Girls was formed to act as the fiscal agent for the Solano Commission for Women and Girls. The Friends of Solano Commission for Women and Girls (the Friends) purpose is to support the Solano Commission for Women and Girls (the Commission) by collaboratively providing funds to support the mission and programs of the Commission.

The Friends will:

- Account for all funds raised by the Commission and Friends collectively
- Give monthly accounting statements to the Commission, including income and expenses, and balance sheet
- Sign all contracts on behalf of the Commission when engaging in any outside vendors, contractors, venues, etc.
- Write checks to cover planned events in a timely manner and distribute to said outside vendors, contractors, venues, etc.
- Serve on the Commission's committees where events are planned that will require funds from the Friends.
- Be an equal partner in all events planned by the Commission, having our legal name on all publicity, programs, radio and news announcements.
- Provide certificate of insurance for all events and name the Commission as additional insured
- Require prior approval for any expenditures when funds are requested
- Disperse any grant funds according to the parameters written in the RFP consistent with the mission of the Commission

The Commission will:

- Have three seats on the Friends Board of Directors, one being the Commission Chair or her representative
- Submit a project/event budget to the Friends before any expenditures are approved, budgets must be submitted a minimum of one month prior to any expenditures or project execution.
- Invite Friends Board members to join committees that will require funds from the Friends
- Work collaboratively with the Friends on fundraisers initiated by the Commission
- Submit expense request using the proper form and procedures set by the Friends Treasurer
- To the extent possible, be organized in a way that requests for funds are given at one time for a specific event in accordance with the approved budget
- All receipts for reimbursement are due to the Commission Chair, Commission Treasurer and Friends Treasurer within one month of the date on the receipt for payment to be processed
- The Chair of the Commission will meet with the Friends President to resolve any grievances
